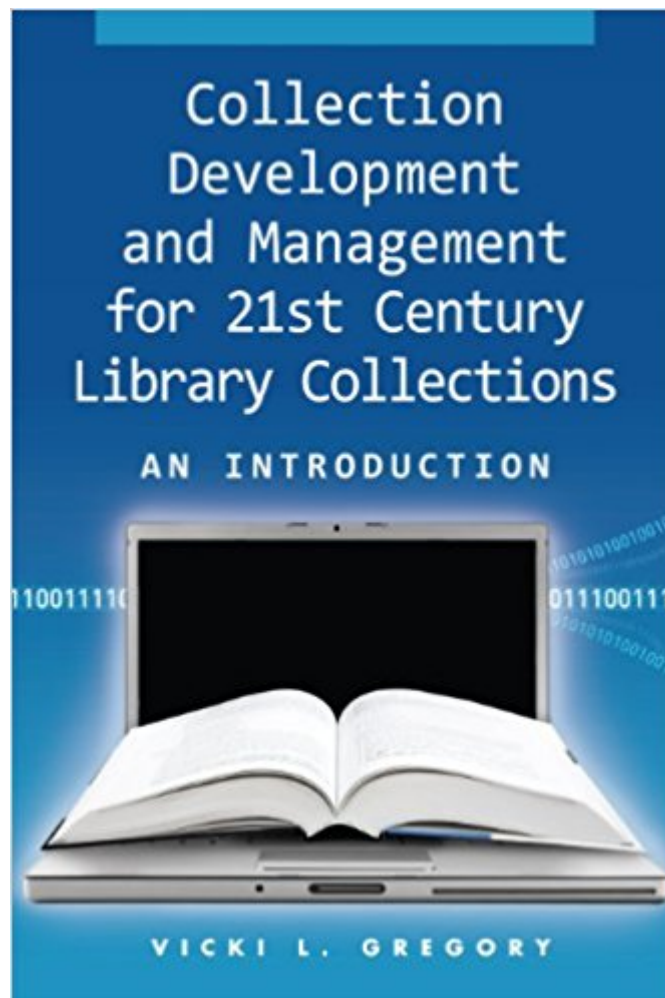

This book also comes with a CD-ROM, which includes 21 PDFs of collection development policies (from each of the major types of libraries) and an Excel spreadsheet with directory information about 360 publishers, distributors, and wholesalers. I highly recommend this book to all LIS students and professors - but it would also be extremely useful for anyone in the field.
