That is not their purpose.What BarCharts ARE: a condensed overview of the black letter law. Use them as a quick reference to understand the material during the semester. Use them as a REVIEW of the material you (should) have already studied for the exam.In law school, BarCharts were the last thing I skimmed over before taking an exam. It's a good refresher.Same with the bar exam. I skimmed over my BarCharts both nights before the exam.
